REPORTING EMPLOYMENT

FORMATIVE REPORTING

Entered the court reporting profession as a freelance reporter. Six months later became a staff shorthand reporter for the New York City Transit Authority. Eight months later became a shorthand reporter for the NYC Department of Investigation. As a result of skill testing, three months later was appointed as an official court reporter to the Circuit Court of Connecticut, at Meriden, CT. Resigned in 1964 to accept provisional appointment to the Nassau County District Court.

President of Verbatim Deposition Service, Inc., a Long Island freelance firm, while working as an official in NYS Supreme Court, above.

PART-TIME FREELANCE REPORTER

Agreed to report two ongoing major litigations during vacation days from Supreme Court position - The Penn Central Railroad Bankruptcy and NYC Transit Authority v Grumman (Flxible Buses) litigations. Depositions continued for several years. Computer transcription was new, there were very few computer reporters in the East Coast, and the attorneys relied upon the litigation advantages of this new technology.

President. Full-time reporter.

Operated this as a "boutique" freelance firm, catering to select litigators in New York. Expanded the same concept to a base in Capitola, CA, London, and Hong Kong. In 1987 brought realtime reporting to clientele and established first court reporter telecommunication between Hong Kong and New York to produce daily copy. Reported proceedings in Cairo, Egypt; Athens, Greece; Rome, Italy; Istanbul, Turkey; London, England (often); Hong Kong (often), and Burmuda.

Created the much-copied "Tursi Transcript Digest" (outgrowth of "Transcript Memo"). Merged into Noon & Pratt (which became Interim) and maintained independent status through November 1996.

Reported departmental meetings for a hearing-impaired computer software developer employed by AT&T. Used the X-Scribe captioning system.

Resigned to accept current position.

First appointed to the EDNY Brooklyn courthouse. In 2000 reassigned to the brand new Central Islip (Long Island) court, located 15 miles from home, still part of the EDNY. Accomplished on two discrete occasions, using a different operating system and CAT system each time. The second assignment unexpectedly required the additional feature of providing same-night file delivery to consultant at MIT. As the date reveals, this was long before the days of reporter emails.

LIVE-NOTE – US INTRODUCTION

First US reporter to publicly demonstrate capabilities of litigation-support tool LiveNote. This took place at Legal Tech in New York City. Exact date uncertain.
