The following are some examples of recent transactions that members of the Investors Private Access Community have completed or are currently receiving income from the investment. Each member highlighted below joined our community made an initial investment which is indicated in the case study and made follow on investments.

## **Client Profile and Investment Pathway**

Jon T. from south Florida is a professional investor and made an initial short term investment of \$25,000 for 90 day term. He generated a fixed interest 6% for the 90 day term or 24% ROI. His initial capital and \$1,500 of interest was paid back at day 64 increasing his initial return to over 24%. Jon made a follow on investment of \$100,000.00 that paid \$2,000.00 per month of the period of 10 months. Jon remains an active member of the community and regularly looks at new opportunities.

Russ F. from Colorado Springs, CO is an Orthodontist and made an additional investment of \$80,000.00 on a accounts receivable advance. He received \$86,0000.00 back in 69 days. He has made several follow on investments and his current position is a \$20,000.00 investment for 6 month term at 24% ROI.

Phil W from Atlanta Georgia is a management consultant that made an initial investment of \$10,000.00 on a long term note at 1% per month. He has received his monthly cash-flow for 18 consecutive months. He made an additional \$5,000.00 investment at an 18% ROI that paid back principal and interest over the period of 12 months.
