INVESTMENT STRATEGY

This Fund is a laddered portfolio of municipal bonds with an average maturity of three to ten years. Laddering involves building a portfolio of bonds with staggered maturities so that a portion of the portfolio matures each year; cash from maturing bonds is invested in bonds with longer maturities at the far end of the ladder. The strategy is a good compromise for managing different types of risk.



Ratings of BB, B, CCC, CC, C and D (the lowest) are considered below investment grade, speculative grade, or junk bonds. We have used ratings from Standard & Poor's (S&P). Where S&P ratings are not available, we have used Mooddy's Investors Service. Where neither rating is available, we have used ratings from Fitch Ratings. "NR" =



The total annual fund operating expenses are as follows: A shares, 0.98%; C shares, 1.76%. Thornburg Investment Management and Thornburg Securities Corporation have contractually agreed to waive fees and reimburse expenses through at least February 1, 2011, so that actual expenses for C shares do not exceed 1.24%.
